INSTRUCTIONS OF USE

Surface must be clean and dry, without remains of previous coats of waxes and resins. Do not dilute or mix with other products. Spread the products uniformly in straight line with a sponge or with a wax applicator. Let it dry completely (1 hour approx) and spread a second coat applicator in a perpendicular way from the first one. Let it dry and required shine will be obtained

FIRST AID MEASURES
